CONTRACT TERMS

BOOKINGS: To secure a date and scheduled Hairstyle times a signed contract is required with a 25% deposit due at the time of signing. The deposit is non-refundable and non-transferable. In the event that the contracted hairstylist is unable to perform the services agreed upon due to an emergency, illness, or unexpected occurrence, a trusted substitute stylist will be assigned and informed of the contracted arrangements.

DELAYS: A late fee of \$25.00 will be charged for every 30 minutes of delay when a client is late for a scheduled time or if scheduled hair services exceeds allotted time because of client delays.

SERVICE LOCATION AND REQUIREMENTS: Location of service for the day-of-event will be at the discretion of the client. A set-up table/work area needs to be made available for the stylist at said location. Ample lighting, whether by means of natural light or by lamps, is necessary for services to be performed properly.

TRAVEL FEE: A fee of \$300 will be added for on-site services in the parish of St. George.

LIABILITY: All professional products are kept sanitary. All tools are sanitized between every application. Any skin and allergies condition should be reported by the client to the team prior to services, and if needed a sample test may be performed on the skin to test reaction (upon request)

PAYMENT: The final balance is due on the day of the event, prior to any service being rendered by any member of Wave House Team – no exceptions. The person(s) responsible for the entire balance of payment is the person(s) who has signed the contract.

CANCELLATION POLICY: Cancellation must be made 7-14 days prior to your reserved date or you will be responsible for the full amount of services agreed upon in this contract.
